Attached are a registration form, invoice and a preliminary program for NACCA's Annual Meeting to be held from September 29 to October 3, 2008 at the Beverly Hilton Hotel, Beverly Hills, CA. Please take advantage of this opportunity to network with fellow regulators from other states and agencies who are dealing with many of the same issues confronting you in the regulation of the consumer credit industry. Your attendance, along with your compliance and legal staff, is strongly encouraged. Please note the following:

- Your completed registration form and registration fee must be returned to the NACCA office prior to August 29, 2008.
- The NACCA program will begin on Tuesday, September 30 at 2:00 pm. A preliminary program is attached with topics including Dept. of Defense military lending updates, examiner training techniques and time management, a presentation on debt management issues, a regulator panel on payday lending updates and the always popular regulator roundtable session.
- The meeting also includes a joint daylong program with the American Financial Services Association on Thursday, October 2. This program provides a unique opportunity to discuss issues of common concern with counterparts in the consumer finance industry. The program includes sessions on the political election update, examinations & licensing concerns, state & federal law updates, the fallout from the foreclosure crisis, and current hot topics concerning regulators and industry. There will also be a luncheon with a local comedian and an evening reception.

- This year's Annual Meeting registration fee is \$400 per person. This fee includes three continental breakfasts, all morning and afternoon refreshment breaks, Wednesday's President's luncheon and Thursday's joint lunch and evening reception with AFSA. The spouse/ guest registration fee is \$150 per person. Your Annual Meeting name badge is your admission to all events.
- Again this year we are offering an Early Bird Registration fee. If your registration form and fee are received before August 29, there will be considerable savings to your agency. Please see the attached registration form for more information on Early Bird discounts.
- A registration invoice is attached. Simply complete the "Agency Name and Address" box and indicate the number of persons registering and total amount of fees being paid, and forward it to your fiscal person. If needed, a personalized invoice can also be furnished to your agency upon request to the NACCA office.
- The dress attire for this year's meeting will be business casual.
- To receive NACCA's hotel rate of \$118.00 per night (plus applicable taxes, currently \$18.56), please call the hotel at 1 (800) HILTONS and reference the NACCA room block.  
**There are a limited number of rooms available. Hotel reservations must be made prior to August 29 and our room block may be sold out well before this date.**

The Beverly Hilton is located about 14 miles from both the Los Angeles International Airport (LAX) and the Burbank/Bob Hope airport (BUR). The Beverly Hilton recommends registrants fly into LAX, so you may want to check both airports for the cheapest fare from your city. Due to the unstable airline industry, you might want to purchase your ticket ASAP.

The Super Shuttle Express (a shared van service) has a discounted round trip fare of about \$30 from both airports for NACCA Annual Meeting registrants. More on this service will be made to all registrants in early September.
